- 1) The above posts are on temporary basis only.
- 2)The Director & Appointing Authority has the right to accept/reject any application without assigning any reason(s) and no correspondence in this matter will be entertained.
- 3) The engagement can be terminated with one-month notice from either side without assigning any reason.
- 4) Upper age limit is relaxable up to 5 years in case of candidates belonging to SC/ST and 3 years in case of OBC category as per DoPT rules. The candidates should ensure that they belong to the OBC category while applying the project posts. Such candidates should produce a valid OBC-Non Creamy Layer certificate in the prescribed format during document verification that he/she does not belong to the creamy layer. The OBC certificate shall not be older than one year at the time of joining the post. In case of not complying with these stipulations, their candidature or OBC reservation will not be entertained.

- 5) Since, the posts are temporary; the incumbents selected will have no claim for regular appointment at ICMR-NIN or continuation of his/ her services in any other project.
- 6) Other allowances like CCA, LTC, Medical Claim and PF are not applicable.
- 7) The results of the final selection will be placed on ICMR-NIN and ICMR websites. No intimation will be sent by e-mail or phone.
- 8) The recruited project staff is eligible for leave as per ^{ICMR} project recruitment rules/guidelines and will have to give an undertaking before joining.
- 9) At the time of joining duty, the candidates should bring all original certificates of educational qualifications (from SSC onwards), No Objection Certificate from present employer (Compulsory), Experience, Aadhaar Card, Community and PWD Certificate (if applicable) for availing age relaxation, passport size photograph along with one set of photocopies of the certificates duly attested (can be self attested) for verification.
- 10) The conditions of employment will be the same as that of the project staff on temporary basis.
