The last date of the receiving of applications will be 15 days from the date of uploading the advertisement in ICMR-NIN and ICMR websites or as on 01 10 21. Applications received after due date will not be considered under any circumstances. The candidates have to download the application form from [www.nin.res.in](http://www.nin.res.in) and fill it with his/her own handwriting and send the same to the above mail along with supporting documents of essential qualifications (**scanned copies**).

**Selection Procedure:** After verification of the applications, the names of eligible candidates will be displayed on the official website [www.nin.res.in](http://www.nin.res.in) for online interviews. **As per the project requirement, based on the Selection Committee's decision the applications will be shortlisted and the link will be sent to the shortlisted candidates for online Interviews through Video call/ Video-Conferencing.** The candidates have to make their own arrangements for Video Call/ Video-Conferencing. The applicants are advised to visit the website regularly for any updates and changes in the recruitment process.

**Terms and conditions:**

- 1) The above positions/posts are on temporary contract basis.
- 2) The Director & Appointing Authority has the right to accept/reject any application without assigning any reason(s) and no correspondence in this matter will be entertained.
- 3) \*Age relaxation is admissible in respect of Retrenched Government Employees, Departmental Candidates (including projects) and Ex-Servicemen in accordance with the instructions issued by the Central Government from time to time. Age concession to the extent of service rendered in other research projects will also be admissible for experienced and skilled persons. Age, qualifications, etc., will be reckoned as on the last date of receipt of applications.
- 4) The appointment can be terminated with one-month notice from either side without assigning any reason.
- 5) Since, the posts are temporary; the incumbents selected will have no claim for regular appointment at ICMR-NIN or continuation of his/ her services in any other project.
- 6) Other allowances like CCA, LTC, Medical Claim and PF are not applicable.
- 7) The results of the final selection will be placed on NIN website only. No intimation will be sent by e-mail or phone.
- 8) The recruited project staff is eligible for leave as per project recruitment rules/guidelines and will have to give an undertaking before joining.
