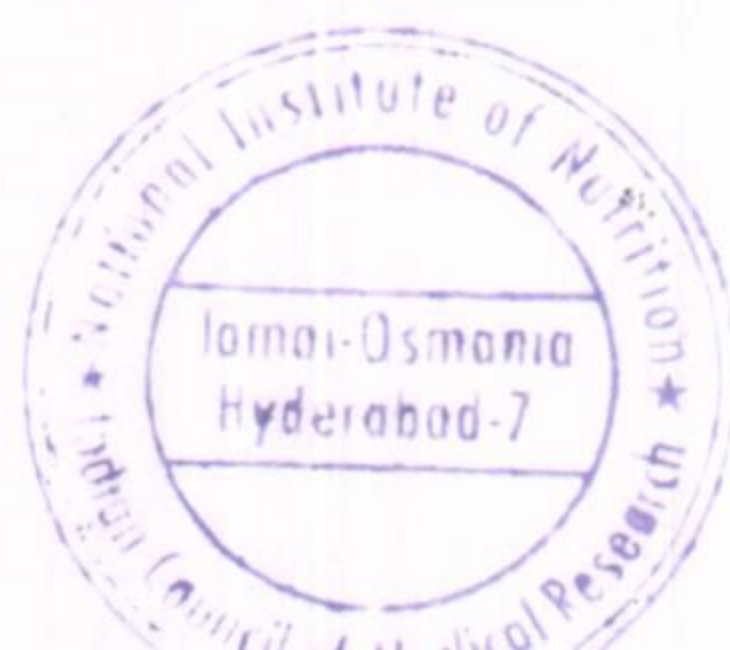

Applications received after due date will not be considered under any circumstances. The candidates have to download the application form from www.nin.res.in and fill it with his/her own handwriting and send the same to the above mail along with supporting documents of essential qualifications (**scanned copies**).

Selection Procedure: After verification of the applications, the names of eligible candidates list will be displayed on our official website www.nin.res.in. Interviews will be conducted for the shortlisted candidates through online (Video call/ Video-Conferencing) to select suitable candidate in later course.
