- 3) The Director & Appointing Authority has the right to accept/reject any application without assigning any reason(s) and no correspondence in this matter will be entertained.
- 4) Age relaxation is admissible as per DoPT rules.
- 5) Presently serving or previously served ICMR-Project employees who have completed three years of project service are not eligible to appear for walk-in-interview. The maximum term of any Project Position in any or multiple projects, with breaks or without breaks shall be three years only.
- 6) Since, the posts are temporary; the incumbents selected will have no claim for regular appointment at ICMR-NIN or continuation of his/ her services in any other project.
- 7) The results of the final selection will be placed on ICMR-NIN website only. No intimation will be sent by e-mail or phone.
- 8) At the time of joining duty, the candidates should bring all original certificates of educational qualifications (from SSC onwards), **No Objection Certificate from present employer**, Experience, Aadhaar Card, Community and PWD Certificate (if applicable) for availing age relaxation, passport size photograph along with one set of photocopies of the certificates duly attested (can be self-attested) for verification.
