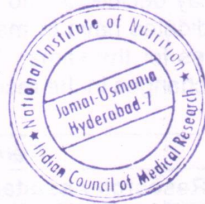
EMPLOYMENT NOTIFICATION

Applications received after due date will not be considered under any circumstances. The candidates have to download the application form from www.nin.res.in and fill it with his/her own handwriting and send the same to the above mail along with supporting documents of essential qualifications (scanned copies).
