Highly motivated and eligible candidates are invited to apply for JRF position (**Leading to Ph.D.**) at the ICMR-National Institute of Nutrition, Hyderabad. The last date for receiving applications is **10-11-2022**. Short-listed candidates will be called for personal interview/discussion with the Principal Investigator/Academic Council of NIN.

Essential qualification: 1st Class M.Sc. in Biochemistry /Microbiology (from a recognized University) qualified with **ICMR/CSIR/UGC/ DST-INPSIRE JRF EXAM WITH JRF FELLOWSHIP ONLY. CANDIDATES QUALIFIED FOR NET FOR PROJECT JRF OR LECTURESHIP ARE NOT ELIGIBLE TO APPLY.**

Areas of research: Biochemistry, Food Safety with experience in handling field studies (food, blood and urine sample collection) and also handling of the analytical instruments like HPLC, LC-MS/MS etc.

Age: Below 28 years as on the date of notification.

Stipend: As per rules of ICMR / CSIR / DBT / UGC.

The candidates should bring all original certificates of educational qualification, ICMR/CSIR/DBT/ -NET JRF-fellowship qualified letter and Community Certificate along with a set of photocopies of the same duly self attested and latest passport size photo and complete bio-data while attending the personal discussion/interview.
