- 4. The offer/quotation in sealed cover should reach the undersigned by <u>5.00 PM</u> on or before <u>23.11.2021</u> and hand over in the Dispatch Section/ Maintenance Department. The offer/quotation received thereafter will not be considered. ICMR-NIN, Hyderabad is not responsible for any postal delays.
- 5. It is the responsibility of the contractor to visit the site before submitting their offer/quotation, for which the bidder may contact I/c Maintenance at 040-27197226/312 on all working days i.e. Monday to Friday except public holidays from 09.00 AM to 05.30 PM.

- 6. Quotation should submit in contractor letter head and sign in each page.
- 7. Certificate of Registration for Goods and Services Tax (GST).
- 8. Percentage of tax (GST) and amount should be mentioned separately in the quotation.
- 9. Discount offered, if any, may be indicated as a percentage of the order value only.
- 10. The work shall be completed within 30 days from the date of award of the work
- 11. The TDS will be recovered as per rules
- 12. The labour engaged and working equipment brought by the contractor for the work shall be recorded in the ICMR-NIN Security Gate before entering into the premises and obtain necessary gate pass.
- 13. Payment will be made against the bill along with a statement of measurement taken in the presence of the contractor and the civil engineer of ICMR-NIN, Hyderabad.
- 14. The contractor/bidder should indicate their Registration Number, PAN, GST, Bank Account number for making payments to the contractor as well as statutory authorities.
- 15. Quotation by email or fax will not be accepted.
- 16. The ICMR-NIN, Hyderabad is not responsible for any damage caused to the labour/manpower engaged by the contractor for execution of the work.
- 17. Bills submitted by the contractor will be settled after certification by the Civil Engineer of NIN with regard to its quality. Any defect in the work has to be rectified free of cost by the contractor within six months from the date of completion of the work.
